### **SUPPORTING DATA**

Clinical study has shown that with regular use of H&S shampoo, there is protection against dandruff and dandruff-related scalp issues, such as itch and odor, for up to 72 hours.

## Test ID: CSD2016209

<u>Test Design</u>: Randomised double-blinded clinical trial among 267 dandruff sufferers. Subjects were asked to use either a H&S shampoo or a cosmetic shampoo (with no AD actives) for 3 times a week, for 3 weeks. After 3 weeks of usage, instrument measurement was taken and subjects completed a self-assessment questionnaire after 72 hours from their last wash. During the 72 hours period, subjects had to refrain from shampooing their hair or using any hair styling products.

#### Result:

Dandruff protection was measured based on the adherent scalp flaking (ASFS) score. The ASFS score was determined by a panel of expert graders, and an ASFS score of between 0 to 14 indicates a visibly "flake free" result. In this study, since ASFS score was assessed after 72 hours since the last wash, having a ASFS score of 0 to 14 also indicates 72 hours dandruff protection.




Figure 1. Reduction in ASFS scores for subjects using H&S shampoo vs cosmetic shampoo, after 3 weeks of usage

Figure 1 shows that subjects who had used H&S shampoo for 3 weeks had a significant reduction in ASFS score vs subjects who had used a cosmetic shampoo.

Table 2 shows that using H&S shampoo provided a greater improvement of self-assessed scalp itch vs a cosmetic shampoo.

Scalp odor is the result of the breakdown of scalp sebum and sweat by the scalp microbiome (Malassezia fungal and bacteria) and/or exogenous factors (e.g. UV, pollution etc). The removal of Malasseiza fungal and sebum, sweat is key to reducing scalp odor.

H&S shampoo contains surfactants that can remove sebum and sweat and cleanses scalp. H&S shampoo also contains the anti-dandruff active, Piroctone Olamine, that can target the Malassezia fungal directly and reduce the Malassezia fungal on the scalp. Figure 1 shows that with using H&S shampoo regularly for 3 weeks can deliver a visibly "flake-free" result vs cosmetic shampoo, for up to 72 hours. Hence, H&S shampoo can also prevent dandruff-related issues such as odor.
